Registration Fees :

1. ₹. 5000/- per family of Life Members and ₹. 6000/- per delegate for Non-Life members.
2. The above delegation fees include:
 - a. Separate Hotel room for families of Life Members. Accommodation from 12:00 noon of 21-02-2014 to 12:00 noon of 24-02-2014.
 - b. For individual non-life members, the accommodation will be provided on sharing basis for the above said duration.
 - c. Lunch and Dinner on 21-02-2014, All meals on 22nd and 23rd Feb 2014 and Breakfast and Lunch on 24-02-2014.
 - d. Conference Kit
3. If anyone (life member or a non-life member) does not wish the organizers to arrange for his/her accommodation, the delegation fees would be ₹. 3500/- for life as well as non-life members. In that case the delegation fees will include the food and conference kit. Such delegates may book their own accommodation at their own cost. The cost difference will not be adjusted in registration fees.
4. However, if any life members who is attending the conference alone (without his family members) and wants the organizers to book an accommodation for him/her, the accommodation will be provided on sharing basis and the delegation fee for such life member will be ₹ 4500/-.
5. Last date for registration: 30st November 2013. No request for accommodation will be entertained after this date, even for the registered delegates, who have initially not opted for accommodation.
6. Last date for submission of abstracts: 30th November 2013.
7. Spot registrations are STRICTLY NOT allowed.
8. In view of financial constraints, registration fees for all delegates, who are life members, even though invited as chairpersons, co-chairpersons, faculty, committee members etc is compulsory.

Note

- 1) Details of accommodations will be communicated to the registered delegates in advance. Delegates shall be responsible for the safe journey from their place to the conference venue and back. The organizers do not take any liability for any mishap/ untoward incidence etc happening during the journey.
- 2) All other extra Expenses to Hotel to be borne by the delegates. The delegates should pay the bills of extra expenses directly to the hotel management before checking out.
- 3) Delegates will be responsible for the personal safety of their luggage and valuables in the hotel rooms.

Instructions to authors for abstract submission

Abstracts are to be computer typed in MS word, Times New Roman, Font Size 12 and are to be e-mailed in following format to argentic2014@gmail.com.

Type of presentation: Oral or poster

Title: Should be bold with first letter of each word capital.

Author/s name/s and affiliation: Should be in capital letters, name of the presenting author being underlined, followed by institutional affiliation and e-mail address of the presenting author.

Contents: Should include the aim of the study, materials & methods, results, conclusion and key words. The abstract should not exceed 200 words. References, tables, graphs or pictures are not to be included in the abstract. Only e-mailed abstracts will be accepted.

No abstract will be accepted after 30th November 2013.

Abstracts submitted should not be published or presented previously & undertaking to that effect should be attached.

Technical information for oral and poster session:

Oral presentation: Only power point presentations will be allowed. The time limit for oral presentation will be 6 minutes, followed by discussion for 2 minutes.

Poster presentation: Size of the posters should not exceed 4x3 feet.

Rates for Stall : Size 10x10 Sq.Ft. Rs. 25,000/- per stall.
